NSC Alliance Comments on Rule Regarding Culturally Unidentifiable Native American Human Remains

On May 12, 2010 the Natural Science Collections Alliance (NSC Alliance) submitted comments to the Department of the Interior regarding a rule that outlines procedures for the disposition of culturally unidentifiable Native American human remains in the possession or control of museums or federal agencies. NSC Alliance called for the rescission of the rule, as the rule "is arbitrary and capricious, manifestly contrary to the requirements of the North American Graves Protection and Repatriation Act ... and patently illegal under any reasonable standard of agency or judicial review."

White House Moves to Streamline Grant Reporting

The White House has announced that it will "streamline" paperwork requirements for federal grantees. New guidelines issued by the Office of Science and Technology Policy (OSTP) direct all federal agencies that fund research grants to use a uniform for collecting annual progress

reports from science grantees. "Ensuring that there are common standards across agencies will ensure that researchers spend less time managing paperwork and forms, and more time producing research results across all science and technology fields sponsored by the Federal Government," said OSTP Director Dr. John Holdren.

House Appropriations Chairman to Retire

Representative David Obey (D-WI), chair of the House Appropriations Committee, announced on May 5, 2010 that he would not seek re-election to a 22nd term this fall. "I am bone tired," he said in a statement to the press. "I am, frankly, weary of having to beg on a daily basis that both parties recognize that we do no favor for the country if we neglect to make the long-term investments in education, science, health, and energy that are necessary to modernize our economy and decline to raise the revenue needed to pay for those crucial investments. I do not want to be in a position as Chairman of the Appropriations Committee of producing and defending lowest common denominator legislation that is inadequate to that task and, given the mood of the country, that is what I would have to do if I stayed." Rep. Obey has served as the top ranking Democrat on the Appropriations Committee since 1994.

NSB Grants Final Approval for NEON

The National Ecological Observatory Network (NEON) gained final approval from the National Science Board on May 5, 2010. The Board voted to authorize the National Science Foundation (NSF) director to award NEON, Inc. a five year contract to construct the observatory network. Construction can begin once Congress appropriates funding. The President's budget request for fiscal year 2011 includes \$20 million for NEON in the Major Research Equipment and Facilities Construction account of NSF.
