Annual NSC Alliance Board elections are getting underway, as per the NSC Alliance Bylaws (<u>http://nscalliance.org/?page_id=16</u>), which state:

"The Nominating Committee shall furnish the names of nominees to the Secretary, who shall circulate them either in written or electronic form (e.g., web site) to the members at least thirty (30) days in advance of the election in order to provide for additional names to be nominated by the membership. NSF Announces Digitization Award Recipients

The National Science Foundation (NSF) has awarded four grants through its Advancing Digitization of Biological Collections (ADBC) program. The NSC Alliance has previously expressed strong support for this new NSF grant program.

One award will establish a National Resource for Digitization of Biological Collections to integrate data from biological research collections around the United States. It will establish and disseminate best practices, coordinate outreach and training activities, assess gaps in information and new technologies for specimen digitization, and ensure that information is accessible online to the public and to biological researchers. This grant was awarded to Dr. Larry Page of the University of Florida Museum of Natural History.

Three collaborative awards will allow for the creation of Thematic Collections Networks (TCNs) to digitize data from biological research collections, and to make the data available online. Each of the three TCNs focuses on a "grand challenge" question in biodiversity. The TCN awards include participation from 92 institutions in 45 states. The three TCNs are titled:

- InvertNet--An Integrative Platform for Research on Environmental Change, Species Discovery and Identification

- Plants, Herbivores and Parasitoids: A Model System for the Study of Tri-Trophic Associations

- North American Lichens and Bryophytes: Sensitive Indicators of Environmental Quality and Change

"This program will markedly increase the accessibility of valuable information residing as 'dark data' in collections to researchers, educators and the public, and will stimulate new research across many fields of science and engineering," said Joann Roskoski, acting director of NSF's Directorate for Biological Sciences.

House Advances 2012 Funding Bill for NSF

On 7 July, the House Appropriations Subcommittee on Commerce, Justice, and Science approved a bill that would fund the National Science Foundation (NSF) at \$6.859 billion in fiscal year (FY) 2012. This is the same amount the agency received in FY 2011, but \$907 million less than President Obama requested.

Despite the flat budget for NSF as a whole, Research and Related Activities would receive an additional \$43 million. This increase would come at the expense of Education and Human Resources (\$26 million decrease) and Major Research Equipment and Facilities Construction (\$17 million decrease). Funding for Agency Operations and Award Management would be unchanged from FY 2011.

The proposed funding level may be a disappointment to some, but others in the scientific community feel grateful that NSF was not subjected to deeper cuts. Funding for the Departments of Commerce and Justice and for related agencies would decline by 3 percent below FY 2008, under the House proposal. "Despite a 6 percent lower allocation than in fiscal year 2011, this bill increases funding for research accounts at [National Institute of Standards and Technology] and NSF," said subcommittee Chairman Frank Wolf (R-VA). "Investments in scientific research are critical to long-term economic growth and job creation."

The full Appropriations Committee is scheduled to consider the draft bill on 13 July.

NSC Alliance Writes to New York Governor, Education Officials about State Museum

On 7 July 2011, the NSC Alliance sent letters to New York Governor Andrew Cuomo and state education officials expressing strong concerns about a recent announcement of staff reductions at the New York State Museum. "The loss of five professional-level Museum Scientist positions, including the State Archaeologist and four Curators (one of which serves as State Paleontologist), will devastate research and collections care in archaeology, geology, and paleontology, making it impossible for the Museum to carry out its core legislated mandates: collections stewardship, research, and education related to the natural and cultural history of the state," wrote NSC Alliance President William Brown.

Act Now: Ask Congress to Promote, not Politicize, Science

The United States House of Representatives will soon consider the fiscal year (FY) 2012 appropriations bill that will fund the National Science Foundation. Some in Congress have recently sought to attack programs within NSF, including mocking specific grants based on titles and inadequate information.

The National Science Foundation is the only federal agency that invests in all fields of fundamental research. It is important that the scientific community stand together to oppose

efforts to weaken NSF, the scientific merit review process, or scientific disciplines that may be viewed as politically unpopular.

National Science Board Seeks Nominations for New Members

The National Science Board (NSB) is seeking nominations for candidates to serve six-year terms starting in 2012. Candidates should have a record of distinguished service; credibility in the scientific, technological, engineering, industrial, public sector, and educational communities; and demonstrated leadership in their field.

The NSB is comprised of 25 members who serve as a policymaking body for the National Science Foundation and as an advisory body to the President and Congress on science and engineering issues. NSB members are nominated by the President and confirmed by the Senate. Members represent a variety of scientific and engineering disciplines and geographic areas.
